6. DISCUSSION/APPROVALAUTHORIZATION OF PROCESS TO PROCURE PROFESSIONAL SERVICES AND CONTRACTOR FOR RENOVATIONS TO BUILDING B

District's General Counsel (Mark Bateman of Young Wooldridge, LLP) discussed with the Board different options available to the district for a process to procure professionals services of an architect and construction manager, and to hire a general contractor, for renovations to Building B. Following that discussion, and upon motion of Director Walrath, seconded by Director Ward, the Board unanimously approved the following: District will publish a request for proposals, seeking professional architectural and construction management services for the project. District's General Counsel is authorized to prepare a draft of such a request for proposals for Board review and comment at the February 2023 Board Meeting. The draft request for proposals is to describe the selection process and a time-frame for same. Once the architect/construction manager is selected and retained, District will subsequently utilize the public bidding process to hire a general contractor to construct the project.
